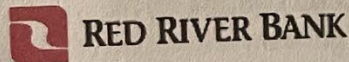

#### 5. Regional Delegate Report – Bob St.

### Regional Delegates Report for July 2025 RSC meeting

Hello all,

Got a couple of things to tell you about. First, we had a “Conference Participants” virtual meeting on April 26<sup>th</sup> .

1. Anthony E, the Executive Director for NAWS, said that the losses from the WCNA were tabulated to have been \$956,129.00. He reported that the issue of how to hold WCNA in the future is on the agenda for the World Board meeting scheduled for May. Asked about Tariff’s impact on our materials, he said “Too early to say... Primary impact is on plastic and metal products... We will have an increase in literature prices proposed no matter what though.
2. Proposed updates to the Guide to World Services were posted for review and comments by fellowship at NA.ORG/conference
3. World Unity Day is planned for 9/6/25... Virtual conference with presentations by various Regions and Zones: [www.na.org/annualevents](http://www.na.org/annualevents)
4. July 12<sup>th</sup> will be “Dealing with Disruptive and Predatory Behavior IDT.
5. Laura B for Human Relations Panel talked about RBZ (Region-Board-Zone) process for nominations.
6. In the Q&A portion there were concerns about the Conference Agenda Report (CAR) survey being repurposed to what is now a survey for literature projects and this being confusing to the fellowship. There were also some concerns about the time line for the CAR survey not allowing enough time for review by the fellowship. Questions about a low cost basic text, maybe just the 1<sup>st</sup> part of it without stories... Anthony reported that when 6<sup>th</sup> edition was adopted, group conscience at WSC was not to do this, and that has to be followed until or unless the fellowship says otherwise.

On April 28<sup>th</sup> the Financial Update came out and I posted it on GroupMe for everyone. If you didn’t see it or want a copy sent directly to you, let Scotty know and I’m sure he can get it to you.

We had another Conference Participants meeting on June 21<sup>st</sup>.

1. Anthony E, Executive Director for NAWS said we will get a 90 day notice of increases in literature prices before they take effect. He warned that no orders would be filled from June 23<sup>rd</sup> to the 30<sup>th</sup> while they conducted a physical inventory of everything. So, if you had an order that got delayed during that time frame, now you know why!

2. Jack H, WB Vice Chair, reported that the WB met in May and while they are discussion what to do with structure/format of WCNA they have nothing to announce just yet. He noted that 2028 will be 75<sup>th</sup> Anniversary for NA.
3. It was announced that Becky M will be the new Executive Director for NAWS on retirement of Anthony E (5-year-contract).
4. Some discussion about travel and lodging for WSC 2026 which will be 5/3-5/9/2026. There will be a form to fill out for Conference Participants requesting to be funded by World vs. those being funded by their service body. All reservations are being made through World though and the cost is said to be \$234 per night with tax. (That's arriving no later than the 2<sup>nd</sup>, and leaving on 10<sup>th</sup>. So 8 nights x 234 = \$1,872 for lodging).
5. Draft motions for next WSC must be in by July 1<sup>st</sup> and they must be in final form by August 3<sup>rd</sup>.
6. The membership survey results will be published soon, but some numbers are: NA is 44% women, 55% male, 1% others. Including Iran, female membership dropped to 39%... 57% attend virtual meetings. 87% have a sponsor... 10% came to NA on MAT... Number still on MAT 4%... but 50% did not respond.
7. Again announced that there will be a webinar on July 12 going over the Issue Discussion Topic material on Disruptive/Predatory behavior, open to all NA members.
8. Laura B, Human Relations Panel (HRP), announced that at 2026 WSC there will be 10 WB seats open, 3 HRP seats open, and 1 WSC Co-Facilitator seat open. Deadline for Region-Board-Zone nominee submissions is 9/30/25.

#### Conference Agenda Report (CAR) Survey:

After somewhere around 500 "issues" or ideas for literature were submitted for consideration, the WB lumped what they thought were similar proposals into like categories. Conference Participants were then asked to vote for 5 of the issues as being the most important to address in this conference cycle. In this way, the issues are being prioritized for the top vote getters to be included in the final CAR.

I posted the raw material (issues/ideas) for you to review on GroupMe, but we had to respond by Sunday, 7/6, so there was no time to gather input from you, the ASRs, directly. So here are the choices I made and some rationale for them:

In the "New Recovery Literature" category, I don't think World should be deciding on the introduction for an individual group. So none of those proposals were chosen. I also think that old-timers are much less likely to use and benefit from new literature, so I did not choose any literature ideas aimed at that group. I haven't heard any complaints about the step-working guide, so I did not choose any of those issues. I've seen the DRT/MAT issue and whether those folks qualify for service and such as an issue in our Region so that was one of my choices. I also see "Ideas and Experience of Spirituality" as an issue in our Region so I chose that one. I see New Members / Early Recovery as vital to the growth of the fellowship in our region so that was my 3<sup>rd</sup> choice. Youth in Recovery was my 4<sup>th</sup> choice, and Recovery behind bars was my last choice.

In Category 2: Revisions to Existing Recovery Literature, while I agree with gender neutral language, I don't think revising existing literature for that purpose is more important than updating/revising content. So, my choices were: Replace references to God with Higher Power... Revise Tradition 11 to include social media... Update "In times of Illness,".... Update "Mental health," .... and update Behind the Walls.

For the "New Service Material" category: I chose - Virtual Service... Fellowship Development... Social media.... Tools for managing electronic funds... and PR tools for Treatment.

In the Revisions to Existing Service Material, there were only 9 possibilities, and I chose: Guide to Local Service... H&I Handbook... PR Handbook... Disruptive and Violent Behavior... and Social Media.

For the category of Issue Discussion Topics, I chose: Use of funds, fund flow and fundraising... social media... Helping addicts find us... Spiritual v Religion... and Tradition 3 and membership/abstinence.

Now, I know that everyone will not agree on the choices I made for our Region, and I'll tell you, I was not happy about being in the position of having to make those choices without more direct input from you. But this was the position I was in and I made choices that I thought best reflected the thoughts and feelings of our Region. I apologize for whatever degree of difference there is between the choices I made and the choices each ASR would have wanted me to make. The silver lining is that there are about 150 others that are making choices and the end result will still need to be voted on by you prior to the next WSC.

I think that's all I have to tell you about. I'll leave Southern Zonal Forum issues for Scotty to tell you about since he will be representing us there this month.

I do want to bring up one other thing though. I don't recall what our practice as a region has been regarding funding of the RD, RD-alt, and RD-alt-elect to the WSC, and we, the RD team, need some clarification on that. In the very near future World will be sending us a form asking about this as well as for specific information on what reservations to make for us.

The financials for this convention stand in contrast to the many successes we can see. Our projected attendance of 24,000 seemed reasonable, given that the previous WCNA had been six years earlier and had seen attendance of more than 21,000. But costs, particularly for AV and labor, increased sharply—and continue to increase across the events industry. The bottom line for the convention reflects expense over income of \$956,129. NAWS' financial policy is always to hope for the best and prepare for the worst. We had accumulated cash reserves against the possibility of an unfavorable outcome, such that the loss was unfortunate but not catastrophic. Our work has continued and will not be

dramatically impacted by this outcome. Our thinking about events on this scale, however, has

Preparing for a world convention has always been a big job. But this year we had fewer staff than previously, and many of our staff are new. As new staff were learning their roles, they were also learning that working for NAWS demands a strong work ethic and a whole lot of good-natured flexibility. This year we brought on a number of new people, and accommodated more work done remotely. We **increased staff** by about 20% compared to last year (six new staff), but we are still about 25% below pre-pandemic staffing levels.

Of course, numbers can never fully capture the *Power of Love*, but we could see that *power in action* in some ways we can measure:

The world has changed, and WCNA attendance was affected like so many in-person meetings around the world. Virtual participation increased dramatically, a trend that has been occurring both inside and outside of Narcotics Anonymous. The livestreamed meetings throughout the convention had startlingly high listener counts. Through the course of the convention, more than 37,500 connections to the livestream were made, including more than 6,200 during the Unity Day meeting. Many of those connections were facilities, groups, listening parties, and local

events. We are honored and humbled by the wide reach of the livestream — and it demands that we think differently about how members want to participate in events now.

We are grateful to all who came and contributed your experience, strength, and hope to make that event the joyful celebration of recovery we all shared in. We regret deeply that the financial outcome did not reflect the beauty of that event.

### 3. Fellowship Development – Richard T.

#### Fellowship Development July 2025 RSC

Hello All!

Fellowship Development has been active in the last quarter. We now have a new group in Rayville which meets on Mondays and Fridays. I have visited with them several times and making sure they have the support they need to get going. Great group of people up there and it looks really promising. There are four rehabs in Rayville and we hope to start getting H&I meetings in them soon. New Life group in Monroe is now meeting four times a week so between them and Rayville there are now six meetings a week either in Monroe or within twenty minutes of Monroe.

Serenity Area had a function on June 21st in Monroe. This was basically a Fellowship Development event to bring awareness to the recovery community in Monroe that NA is alive and growing in Monroe. Aaron D from Monroe and Floyd G from Shreveport were the speakers. We had approx. 75 in attendance and everything went great. In addition to addicts we had several councilors from rehabs in attendance that requested NA material and were excited we were there.

I've been in working with the groups in Natchitoches and they are doing well. They have an NA Conference coming up on July 26th. I will be one of the speakers and most of the other speakers will be from around the region. I'm attaching a flyer with this report. While they are not currently part of LA Region we are working much closer with them than in the past and have a much closer relationship. I'm hopeful that they will affiliate with us in the future. Their meetings are now listed on the Central Area meeting list so their meetings are much more visible and accessible.

Jared L is producing four videos targeted for TikTok and Instagram that should be available by the end of July or early August. The cost is \$3000.00 total and is part of the approved 2025 Fellowship Development budget. Most of the social media budget for 2025 has been reserved for getting these PSA vides out there when they become available, I also ran a 30 day Facebook campaign targeting a 18 to 45 audience and have the results attached to this report.

To my knowledge the larna.org problems either are fixed or in process of being fixed. The Area websites that I admin are all up and running and I'm still slowly upgrading the backends to current operating system releases. The Region Helpline is working fine and I hope to do a major update on it by the end of the year that will fix the reporting and some other minor glitches.

I don't have a budget for 2026 but will have it at October RSC. I hope to have one or more fellowship development subcommittee meeting between now and then to get this together.

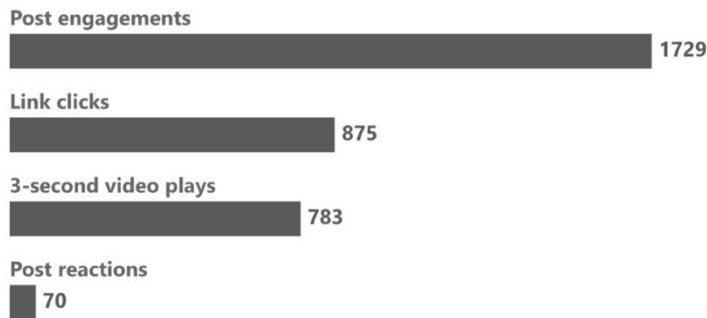

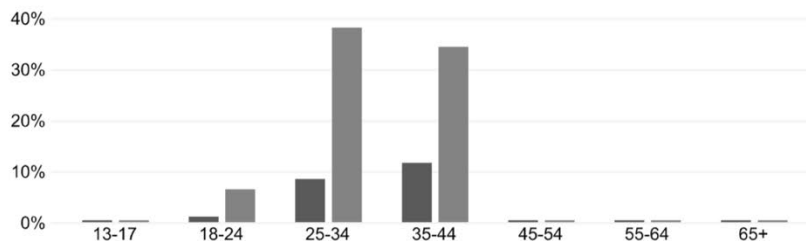

LRCC Financial Report for Louisiana Region - July 12-13, 2025

Final Financial Statement for Convention XLI held May 23-25, 2025. The Financial Statement is attached. In summary, the convention met neither the projected income, nor the projected profit, however, they did net \$8,313.14. The original seed money was transferred back to the LRCC main account on 6/20/25, leaving the net profit-or surplus as regards 501(c)(3) organizations in the HCC account. The board will need to decide today how much, if any, should be sent to Louisiana Region as a donation. It is suggested that additional funding be retained in the LRCC main account since we do not yet know fully how to plan for Convention XLII which will be held in New Orleans May 22-24, 2026.

HCC-2026 Bank Account. Our third account, which had an opening balance of \$500.00 has been set for use by the HCC for next year. Because that HCC does not currently have a treasurer, it was suggested at the end of the 2025 convention that the LRCC Treasurer will maintain those records until such time as a competent individual can be seated by the HCC. With deposits from Early Bird Registration and Raffle Ticket sales, as well as the expense for the Charitable Gaming license, the balance in that account is \$1,748.26. The LRCC board needs to develop a budget before fully funding this account.
