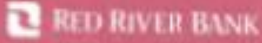

June 24<sup>th</sup> & 25<sup>th</sup> 2023

This report is “bittersweet” as it will be my last report to the Region. It has been my honor and privilege to serve the Louisiana Region! In keeping with the “Spirit of Rotation” I will not be seeking another term.

WSC 2023 “Creating Our Future” was amazing, difficult at times and well worth our presence and participation. We got a lot done and there is always more work to do in our Fellowship. Here are some highlights from WSC 2023.

**This was the first truly hybrid World Service Conference, with 39 participants attending virtually.**

**A Visions for NA Service was revised, changing the phrase his or her to “their”.**

**Virtual meetings were officially recognized as groups.**

**The following Issue Discussion Topics were approved for the upcoming two years. Thank you to all who participated in the CAR survey.**

**\*Dealing with disruptive and predatory behavior**

*“Predatory behavior means any conduct evidencing egregious, habitual or continuing attempt to misuse power, authority, position or situation to abuse or exploit/control others, as well as deliberate attempts to entrap persons to commit sexual acts”*

**\*Gender-neutral and inclusive language in NA literature**

**\*Reimagining and revitalizing service committees**

**\*DRT/MAT as it relates to NA**

And, so much more! I really hope that we were able to cover all the ASR’S questions on Saturday. Any last-minute questions about the post Conference Report?

Southern Zonal Forum is coming up July 28-30<sup>th</sup> 2023 in Murfreesboro Tennessee. There will be an election and the possibility of a new position being created at SZF. I apologize in advance that I did not get the information out to the Area’s in

advance of this vote. There is a vote for the new Zonal Delegate. The Facilitator (of the Zone) and the creation of the "Virtual Audio/Visual Coordinator Position" which is highlighted in the SZF Minutes. If you (Region) would like, I am willing to attend (Virtually) and cast your Area's vote on July 30<sup>th</sup> virtually at the Zone. What that means exactly is that the ASR's would bring the motions/proposals to their Area and either email, text or call me with their vote. This is completely up to this body as I don't think that we'll have a sitting RD in the month of July. The Nomination(s) could be sent back to the Group's for a vote (?). Unfortunately, I will not be in attendance physically and if any of you are interested there's a virtual link on the flyer that I'm sending around. Some of our Admin committee (Nikki & Doug) and I were able to meet virtually and try to come up with suggested Guidelines changes for the RD, RD Alt and RD Alt Elect positions timelines. These can be built upon as the WSC cycle has changed from two years to every three years on a trail basis. (This is for two cycles; a decision can be made to change it at that point.)

I am requesting \$891.05 reimbursement for my hotel room stay (9 room nights) at the WSC. N.A.W.S. paid (\$600.00 roughly \$65.00 per day) for my daily meals. I used/spent \$450.00 of this allotment and returned to them \$150.00. Receipt(s) are included and turned in to our Treasurer. We (the Region) normally send that allotment back to N.A.W.S. I may have a one room night stay here in Covington for \_\_\_\_\_ that I am requesting from my budget.

Greetings from the Convention Board

Hope this weekend finds you all well. Unfortunately, I will be unable to attend, I am at a glass conference in Washington. However, Ron D and Vice-Chair, Denise H have agreed to fill in for me. It has been a busy few months since my last report. Bob Storer, Virginia Williams, and Paul Payne have completed two (2) terms on the board. That's eight years, Thank you for all the hard work. That means that we have three openings as of June 1<sup>st</sup>. I sent you the requirements for the qualifications for the board in April but will include a copy with my report. On top of that we had a convention.

**Board goings on**

The convention was a spiritual as well as a financial success. I will not have the final information from the convention until later this month, but everything looks good. I have included in the information that the hotel sent us on rooms utilized as well as food and beverage. Just for the record, what I give the Secretary will be: Board minutes from May 2023, treasurer reports and convention committee reports. I am still waiting for the final minutes and treasurers report and convention committee bank transaction report from their Secretary Ric S, but hope to have them in the next few days, once I get them I will forward them to Don. I would like to thank the convention committee members and the members of this Region and the NA community in general that made this convention the success it was. There were people from all over the state as well as people from all over the country. Thank you.

**Convention 2024 and beyond**

We are still looking for a convention bid for 2024 and beyond. However, One of the things that we realized once the convention was in progress was the mix of people from all over the state. The Baton Rouge Marriott is centrally located with easy access to I10, has reasonable room rates, free ample parking and all of the meeting space we need. During the course of the convention, we were approached by our sales contact, Michelle Phillips. She told us that the hotel would welcome us back should we want to return. What that left us with was a hotel but no convention bid. Conversely, we have areas in the region that have willingness to put on a convention, but no hotels large enough, or no meeting space to put in a convention bid. The thought was, speak with a few members

from those areas with willingness, but no hotel and put them together with the Marriott.

Having said that, we have heard from a group of people that may be interested in putting in a bid and will hopefully be able to report something on this on Saturday/Sunday. It could be people from across the state. It would allow people in Areas that have never had the opportunity to put on the convention, to be able to participate. They will have to go through the normal bid process, but there is no reason that the host hotel has to be in the same city as the host committee. This will also give HCC members the opportunity to gain convention experience. This goes a long way when you are putting on a convention. In 2019 the convention that was to take place on the Northshore closed, that forced us to find another hotel, we had it in New Orleans, the convention went on to be very successful.

### **Final thoughts**

I had forgotten all of the feelings that make up being involved with putting on a convention. Three years was a long time to go without one, there were a few hiccups, for sure. However its nothing that can't be remedied. At the end of July we will sit down with the members of the convention committee and discuss changes that they would like to see incorporated in the convention guidelines. We will include some of them, along with some of the changes that members of the board might like to see made and hopefully come up with amended guidelines that will make the process smoother. We will also review the budget process. The budgets in the past have worked wonderfully, this one did not. One of the things that we did not take into account was inflation. We underestimated the cost of some items and the availability of others. This is something that we need to take a close look at. We will also deal with the finances, funding the next convention, the board and the rest is forwarded to the region. Having looked at the last bank statement from the convention committee, but not the last expenses, its hard to pin down the exact amount. However, it should be between \$15,000.00 and \$20,000.00 or so. We will have to wait for the committee minutes and treasurers report to know for sure.

As I said earlier, we will be having three members roll off the board in June. Bob S., Virginia W., Paul P. Thank you for the last eight years of service to the region.

The Region elects the board members, so hopefully there will be nominations at the June Regional meeting. I will furnish a list of qualifications if Don does not already have them. We are also looking for bids for the 2025 convention, just sayin.

### Bayou Recovery Area ASR Report: June 2023

**Number of Groups:** 12 individual home groups holding 16 meetings weekly

  - 14 in person meetings, 1 zoom meeting, 1 Hybrid in person and zoom meeting
  - Average meeting attendance: approx. 20+/- Note: we have experienced an increase in attendance in the last couple months at several meetings.
- **Number of H&I meetings** per week:
  - Number of treatment centers and locations Commitments: We currently service 3 treatment centers:
    1. The Grove, Sorrento - every Friday\*\*all outside meetings are currently on hold until further notice per Facility request.
    2. Woodlake, Ethel, LA- every Monday
    3. Progressive, Central/Zachary- every Sunday
  - Number of Correction Facilities and Locations Commitments:
    1. Angola-2<sup>nd</sup> & 4<sup>th</sup> Saturday of each month\*\*I'm not sure what is happening with Angola. There have been a lot of issues with the facility and a lack of support.
    2. DCI-1<sup>st</sup> & 3<sup>rd</sup> Wednesday or Saturday each month
    3. LCIW-1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup> Saturday mornings Avg 15 people
- **Total size** of Bayou Recovery Area Fellowship: approximately 150+/-
- **H & I Activity/plans:**
  - Bayou Recovery Area is continuing to work with the DOC on volunteer orientation issues. Angola, DCI and LCIW are having problems with the approval process. DOC clearance certificates are not being issued and our Area is working diligently to resolve this. There has been little to no progress in this area. The volunteers have been oriented and their paperwork submitted, but DOC isn't responding to our Area's request for clearance certificates.

  - H&I Learning Day- a potential plan is in the works for an H & I learning day/orientation sometime this year. More will be revealed.
