**1. Chairperson – Pixie S.**

Hello Everyone:

I attended our last PR meeting in the Bayou Recovery Area. Richard has done a great job researching the various ways we can carry the message. If people don't know how to find us, we cannot help them which in turn helps us. We have an opportunity to make a difference here by supporting these motions in new business.

I want to also thank James for all the hard work he has put in allowing us to meet this weekend. He found a place for us to meet and to put on the function last night all within budget. It was not easy. Thank you for your service James. I do not know if this will be possible again especially in this area. I would like to suggest that we look into increasing this budget or have a discussion about increasing it for this area the next time we meet.

Meeting started around noon. Elections were held and Allison L was elected to Secretary for the Regional PR Subcommittee. Richard T opened the meeting by handing out proposals from Lamar Advertising, Jared LaReau Films, and Facebook/Instagram (Social Media). All handouts are attached. All discussion centered around 3 campaigns to increase public awareness about Narcotics Anonymous with a total approved budget of \$5950.

- Billboard PSAs \$2500
- Video PSAs \$3000
- Social Media PSAs \$450

**Billboard Campaign:**

Richard explained that Lamar Billboard space was now limited due to Hurricane Ida. PSAs are placed on surplus (non-rented) boards and due to extensive storm damage, surplus space is now limited for this year and 2022. Lamar was uncertain as to when more surplus space would be available for Vinyl advertising. Free Ad space on electronic billboards would only be available for "dead space" times but would still pursue. Billboards (electronic and/or vinyl) will not be available in all markets (areas) of the state. It was pointed out and agreed upon that any billboards placed along I10 and I12 would benefit all areas as these are the main thoroughfares in the state and most people travel those highways at some point so specific markets shouldn't be a deterrent to proceeding.

Discussion ensued about the project budget, PR budget, measuring outcomes and approval process from Region. The Region Helpline and Website will be on all advertisements and calls/contact information will be routed to the Areas via YAP/phone and/or webistes.

**MOTION:** Pixie S made a motion that we approve up to \$2500 for 25 Billboards in available markets and free ad space on electronic billboards along the highway. Motion was 2<sup>nd</sup> by Robbie and the vote was unanimous YES.

**Video PSA Campaign:**

Richard introduced Jared L and together they explained the proposal for two video PSA shoots: a 15 second PSA and 30 second PSA. The cost would be \$2950 for both PSAs and NA would own the films. The cost includes:

Film Studio

Video Equipment Use

Grip & Electric

Film Crew

The PSAs would be used for TV, Region & Area Websites, Social Media Sites and would be produced by Jared's company. The video templates could be manipulated for use in any area. Jared stated he would work with the Regional PR Sub-Committee to write and approve a script and addicts would be filmed with their faces blurred out.

**MOTION:** Bob S made a motion to approve up to \$3000 for two video PSA shoots. Motion was 2<sup>nd</sup> by Trevis and the vote was a unanimous YES.

**Social Media Campaign:**

Richard discussed the handout on Facebook performance metrics based on dollars spent. Money spent would be to boost our posts on Facebook and Instagram. The audience for post boosts can be selected for the whole state to target any demographic or all demographics. For \$100 per month our PSAs would reach 160-460 people who would be directed to the website and phoneline. There are measurable outcome metrics with social media Platforms. Discussion centered on the importance of using social media to inform the public about Narcotics Anonymous and the cost effectiveness of using social media to attract new membership. The video PSAs can be used on social media as well as picture/written promotions.

**MOTION:** Nancy S made a motion to approve \$450 for social media post boosting on Facebook and Instagram for a 6 month trial period. Motion was 2<sup>nd</sup> by Jared L and the vote was unanimous YES.

## DESIGN & FINISHING SPECIFICATIONS

Updated 3/2017

The following specifications can be used when creating a production file for Lamar's static Bulletin inventory. The exceptions include TrVisions, J-Bolt panels, and Wallscape. If you prefer to download a template in .PDF or .TIFF format, go to: [lamargraphics.com/lgn/Prod-Temp.asp](http://lamargraphics.com/lgn/Prod-Temp.asp).

### PRODUCTION RESOLUTION

Lamar Bulletins are set up 1/2" = 1' scale @ 300ppi document resolution. This equates to about 12.5 pixels per linear inch on the final product.

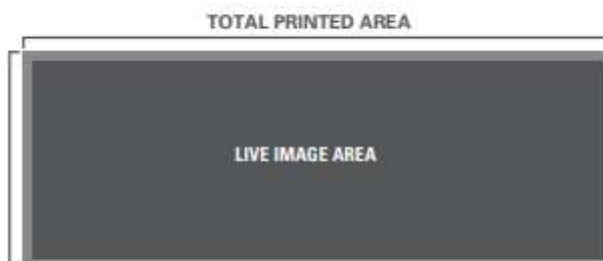
### MECHANICAL SPECIFICATIONS

Hold your design to the dimensions of the structure. The structure size represents the actual image area of the billboard.

Bleed your background by 6" on all four sides. This makes the overall vinyl size 1' larger than the image area in both height and width.

The production facility should make 3" pockets on the back of the vinyl for installation. This does not change the overall size of the vinyl.

# CreativeTIPS

**Legible text** is big and high-contrast.

## Use large and sturdy typefaces.

Fonts selected for out of home designs should be easy to read from variable distances. Fonts with thin strokes or ornate script will be difficult to read.



## Color contrast affects readability.

A background with high contrast makes smaller text possible.

A busy background behind text will reduce readability.

Greetings from you Louisiana Regional convention Corporation

Let me introduce myself, I'm Bob S, new chairperson of the convention board. We held our committee meeting October 31, 2021. One of our first order of business was to discuss the treasurers report, go over bank statements and discuss the current events involving the boards tax status. We have recently tried to resolve the issue using legal zoom.com. We paid them a fee to file an amended 1023 EZ tax form with the IRS. Unfortunately, since we had a revocation, they are not able to file the 1023 form that we will need to reestablish our tax status. They agreed to return our full fee which will be returned to the board.

**Incorporation update**

The next course of action was to find a CPA who would be willing to take on our case. I sourced a CPA who I have a relationship with. His name is Gus Levy of the Levy company in Baton Rouge. We signed a power of attorney with him (with the board's approval) to act on our behalf and do whatever it is legally to get us reinstated. He or his company will be the only ones able to negotiate with the IRS. There's no sense in speculation as to how long this is going to take. I will keep you up to date on our progress as I was the voted by the board to take care of that task.

**We need volunteers to put on the convention in 2023**

Our next of action was to discuss what we need to do to get a convention up and running, The Bayou Recovery Area has given its blessing to a small group to search for the hotel to have it in, Unfortunately along came a hurricane and as well as an acute labor shortage at those hotels and COVID on top of it., After repeated unreturned phone calls from the hotels and no movement, the board decided to set a deadline for some sort of contact from the hotels as a deadline of December. That deadline has come and gone. Unfortunately, there will be no Louisiana regional convention in Louisiana in 2022 We are now shooting for 2023 for the next convention.

Our hope is that we can find an area, or two areas willing to join together to put on the convention. We need a place and that areas blessing. The Board has a huge

amount of experience and enthusiasm to get this done. Please help, talk to other members, speak with your areas.

I was on the original committee to incorporate the convention, I stayed while we tried to work out the mechanics of it but my term was up when it came time to implement things. Fast forward to present times. As the newly elected treasurer in 2017/2018 I filed taxes with the IRS. The

form is the 990 N form. Extremely straightforward, with a minimal amount of questions. When I went to file it the next year, I was informed that we had our status revoked for not filing taxes for three years in a row. From what I have been able to ascertain after my contact with the IRS, other than the attempt in 2017/18 no one had ever filed taxes before. I did have a brief conversation with the IRS at that time, they suggested that we gather our documents and try and appeal/reapply. I explained that in 2016 Baton Rouge had a flood that resulted in them being declared a federal disaster area. And as a result, all the records from our past as well as the current checkbooks and all other material was lost to the flood. They stated that we would most likely have to reapply. Then came covid.

That brings us to the present. After our attempts to use legal zoom, my hope is that our ne CPA will get our tax status reestablished. Its not going to be fast, if you ever had to deal with the IRS, you already know that. I will keep you informed

As far as the bank accounts, the LRCC has 3 accounts, all accounts directly tied to the LRCC EIN number. We have no access to the Regions bank accounts. We changed that at least 6 years ago. We also moved on from Capitol one to Regions bank, way too much drama.

### **Future Games**

NA has been asleep for the last couple of years (due to Covid) for most of the region and a huge part of the world. New Orleans has managed to pull off a well attend and great convention, which gives me a lot of hope for the convention's future. We need to do this together. and we can. Please go back to your areas and see what they can do. The board will be discussing alternative methods that we can use to put on conventions. Any Input that you may have will be greatly appreciated.
