All orientations will be held at South Baton Rouge church of Christ, 8725 Jefferson Highway, Baton Rouge, LA. 70809. Doors open one hour before the orientation begins. H & I goes into Angola (camps C & D) every second and fourth week of every month. Angola has meetings every Saturday in camps C & D. H&I goes into the womens prisons every Saturday as well, LCIW and Jetson alternating weeks. The Lake Area has conducted 2 H&I orientation and have oriented 35 ppl to service the H&I commitments. I am attaching the H&I orientation packet for your H&I rep from your area to use for any orientations. I am asking that every area service representative please give me the contact number for your H&I rep in your area so I can contact them to set up an orientation. I am free most weekends to travel and conduct orientations. I am also working with Allen Correctional Institution about brining in a H&I panel into the prison. I am waiting to hear from the Assistant Warden about what training needs to be done and what background checks need to be completed so we can get it started. I will be requesting money to send to Hunt to order literature and send via the Col Brown and Maj Linzy. Their literature was destroyed when the roof collapsed. PR has been busy since last RSC. On June 1<sup>st</sup> there was a workshop at River City's Club House in Alexandria. It was attended by NA members from both Central and Bayou areas. Allison L. from Bayou Area led a discussion on Poster Day and Richard T gave a presentation on the BMLT. The workshop attendees all agreed that we should have these workshops on a regular basis as it was a positive experience to meet and exchange ideas. I'd also like to thank Sean S for giving a presentation to Unity Area on the BMLT/YAP. There was a meeting with Lamar Advertising in Baton Rouge. The salesman said we could get billboards put on their unsold inventory for just the cost of the vinyl. Unfortunately his boss had other ideas. They offered us a discounted rate that is still too expensive to be practical for us. Currently trying to find another avenue for this. All ideas are welcome. We've made a lot of progress in getting representatives from each area trained to keep up their own information in the BMLT database. Hopefully all areas will be on board by the end of this RSC. It is important to keep this database accurate as this is the master that we use to update NAWS and it powers all the online searches on NA websites. It is/can be used to generate Area and Regional printable meeting lists. I periodically google Narcotics Anonymous Louisiana and see how Region and Area websites are ranked. While doing this I noticed a "Narcotic Anonymous Center" in New Orleans – with the address of a vacant lot in Baton Rouge and the phone number of an Accura dealership. I did a little forensic work and found that the site was hosted on Linode. I went through their complaint procedure and the site was taken down in less than 24 hours. Nice to get a win every now and then. Central Area has a new website <https://cenlana.org>. They area holds ownership of the domain and have complete control over the hosting, etc. If other areas need help with their website or implementing BMLT features within their website then let me know. I do this free of charge for areas in the region and will be happy to work with and/or train webservants in your area.

## Information of Interest

### B. O. D. Chairperson

Members and Trusted Servants of the Louisiana Region:

As is our custom, we are including minutes for the HCC meetings (LRCNA 37; and LRCNA 38) and the LRCC Board meetings along with this report. Let me jump right in with the extraordinary events of the past three months. On April 26<sup>th</sup>, just 3 weeks before LRCNA 37 was supposed to happen at the Clarion hotel in Covington, I got a call from LRCC's liaison with the hotel, Denise Howell. She informed me that the hotel had just contacted her and stated that the building was being sold and that our contract was being voided. We did have a clause in our contract with the Clarion that said if for some reason the hotel could not honor the contract, they would be required to assist us in finding an alternate location. We asked them to honor this clause and they soon replied that the only location they had found that would be available was in Thibodaux. In addition to this location being much too far from Northshore, the meeting space was less than what was available at the Clarion. Denise and Bob Singer, the LRCC Treasurer, then began making calls to see if there was another site that we could possibly get an agreement with to hold the convention as planned. My understanding is that they primarily focused their attention on New Orleans and Baton Rouge as possible alternate locations as other areas would be too far away to coordinating everything. By the end of the day, however, we had no leads for an alternate location and realized that even if we found a suitable site, negotiating a new contract, working out the logistics with a new hotel for meeting rooms and set ups, and getting the word out to everyone that was planning to attend, would simply take more time than we had. The board then made the difficult decision to cancel and began to work on getting the word out as quickly and effectively as possible. We decided that the best way to do that was through announcements on both the Regional website and the Convention website. That announcement was then picked up by Facebook groups and by individuals and re-posted. The HCC also started calling out-of-towners that had registered, speakers, vendors, and contractual providers. Finally, I also sent an e-mail to all of you through Nikki B. advising you what had happened and what we were doing. The next week, the HCC met and discussed their options (May 5<sup>th</sup>). The first was to walk away. The second was to submit a bid for the 2021 LRCNA. The third was to ask LRCC to try and find an alternate site, negotiate a contract, and hold the convention at a re-scheduled date. Rescheduling carried the additional problem of giving the HCC enough time to make all the arrangements, re-confirm speakers, vendors, and contracts, or find new people, while not causing a problem for LRCNA 38. Remember that normally, the next years convention starts selling merchandise, collecting pre-registrations, and setting up fundraisers immediately after the previous years convention, in June. The thinking was that while rescheduling would make it more difficult for LRCNA 38, that as long as LRCNA 37 occurred within 90 days, 38 would be OK. After much discussion, the HCC voted to allow LRCC to attempt to find an alternate location for the dates of August 23-25<sup>th</sup>. There were some leads on possible hotels from HCC members, and somehow the RD got called and he contacted the Convention Visitor's Bureau for New Orleans. That generated a number of additional leads. LRCC identified two hotels in New Orleans as likely good sites. The Hampton Inn and the Marriott, both on Convention Blvd. We went to both that Friday and reviewed proposals in the LRCC board meeting that Sunday (May 12<sup>th</sup>). It was our opinion that either of these hotels would be a good fit for us. We then contacted both with additional requests regarding room rates, meeting space charges, etc., and got what we thought was a better contract offer from the Marriott. Before signing the contract though, our bidding guidelines require that bid committees get the approval or "blessing" of the hosting area. The HCC had done that with the Northshore area, but now we were looking at having it in the New Orleans area and therefore we thought we needed to go to that area and get their blessing before proceeding with the contract. I and several other board members as well as the HCC chair, vice-chair, and other interested persons attend the NOASC meeting on May 19<sup>th</sup>. We advised them of what had happened and that we wanted their blessing to hold the rescheduled convention in that area in August. They gave us their blessing and the contract with the Marriott

was signed on May 20<sup>th</sup>. Since then, the HCC has done a site visit, they have worked out where they want meetings, workshops, hospitality, etc... The Saturday night speaker was not able to make it for the new date, and they have chosen a new speaker for Saturday night. The band they had contracted with for Saturday night also could not make the new date, but they have now chosen a new band for that night. There is still a great deal of work to do in preparation for LRCNA 37 but the HCC appears to be making good progress. I hope that any of you that have not yet registered and gotten a room at the Marriott will do so before the end of this weekend. Our deal with the Marriott is entirely dependent on us filling our room block of 200 room nights. In the board meeting on May 12<sup>th</sup> we discussed the possibility of filing a law suit against the Clarion for breach of contract. We did consult with an attorney and they told us that we do have a winnable case. However, that process would take some time, likely years, and the legal fees involved are inestimable. At the most, if LRCNA 37 rescheduled loses money, we can genuinely claim that their breach of contract cost us whatever that loss would be and probably about 10-15 thousand dollars. But if LRCNA 37 is financially successful, that amount would shrink by whatever is brought in, and again, we have no way of estimating the legal fees involved in such a suit. The feeling of the board is that this is too risky and not worth the effort. However, we want to get feedback from the RSC on this issue since we are here to serve you. Financially, LRCC has been able to absorb costs associated with these events so far. For example, we purchased a Panasonic Toughbook for the HCC to use just prior to being notified of the contract breach. An individual board member paid for that, about \$800, expecting to be reimbursed by the Board for it. At the same time, LRCNA 38 was expecting the balance of their seed money at the end of may from 37 and they had pretty much spent what little they had to begin with. The board member was willing to delay being reimbursed and we were able to come with some money from our budget that hadn't been spent yet and give 38 funds to keep functioning until 37 takes place. Speaking of LRCNA 38, the contract has been finalized and we are waiting for the countersigned copy to come back to us from the hotel. You may or may not have heard that their Vice-Chair, Robbie L., had a bleed of the brain. He survived but he will need rehabilitation therapy for quite some time and will not be able to continue as the Vice-Chair. He gave Wanda his verbal resignation with his mom present as a witness and the HCC is now making announcements for an election of a replacement Vice-Chair. Once they elect someone, that person will then have to come to the next board meeting for confirmation. Lafayette is working on a bid for LRCNA 2021 and my understanding is that they will be presenting it to the board at the July 21<sup>st</sup> meeting. Since they are the only ones that we are aware of that have a bid ready, provided the board sees that bid as "valid," they will come to the RSC meeting in October asking to be granted LRCNA 2021. You'll remember that we talked about vacating our storage area since we will be keeping banners in digital formats rather than the actual banners and putting all the RSC materials in bins so that you can go through them and see if there's anything you want to keep. Those materials have, in fact, been given to the RSC chair now. Another issue we would like to get feedback on from the RSC is the timing of LRCNA. Since the establishment of Bayou Country Superfest on Memorial Day Weekend, hotel space from Baton Rouge all the way to New Orleans has become difficult to find and what is there is quite expensive. In Baton Rouge there are literally no hotels with space for us on that weekend. So far we have adjusted to this by shifting the dates to the weekend prior to Memorial Day. We're wondering if we shouldn't think about another time frame entirely and would like some feedback from you on that. If you think moving the time of LRCNA would be a good thing, then what do you think is a better time for it and why? Finally, our next board meeting is July 21<sup>st</sup> at Bob Singer's. We do it at a board member's home so that we can socialize and relax a bit before the formal meeting and provide an opportunity for the finishing HCC to share information with the upcoming HCC. This is also the meeting where we normally review the guidelines and make changes and updates as appropriate, but given that 37 has not happened yet, I'm not sure how much of that we'll do at this meeting. In any case, the formal meeting will start at 2:00 and after this, our meetings for the coming year will be held at Grace Baptist Church on Richland Ave in Baton Rouge.






