We were only out of synch with NAWS by four meetings over the entire region and these were new meeting that just hadn't been registered yet. I have spoken with the areas involved and will confirm to NAWS that those meeting are correct and they will be automatically registered with them. You guys are awesome. Keep up the good work. I plan to do this comparison once per quarter right before RSC. If any individual areas want to synch their BMLT data with NAWS at other intervals then let me know and I will show you how to do it. Thanks everyone for sending in all the event flyers to post on larna.org. It has gone from virtually empty to showing a lot of activity around the region. Very nice to be able to see everything in one place. Now if I could just get away to attend more of them. Keep sending them in! The Regional Helpline we've been testing has been up for several months now. The number is 585-DONT-USE (585-366-8873). Currently it is hosted on one of my servers for development purposes but will be moved to one of Steve Scranton's servers if we decide to go live. Steve has been great to work with and I give him my thanks. If you haven't tried it I encourage you to do so. This number works both as a meeting search and a gateway to forward calls to each areas helpline. Let me know what y'all think. We're working on getting area webservants up to date on Yap, BMLT and other tools to allow them to offer new options. We still have work to do but it's getting better all the time. Allison L from Bayou Recovery Area and Jared L from NOANA are working together to get a PSA together for LSU, I haven't got a current update but it sounds promising, It's been a productive year so far and I'd like to thank everyone for their efforts to make it so. We hope to keep up and expand on our current projects and move on into other areas. I'm thinking of setting up a closed facebook group for LA Region PR. Information of Interest

Members and Trusted Servants of the Louisiana Region:

As is our custom, we are providing you with the minutes for the HCC meetings (LRCNA 37; and LRCNA 38) and the LRCC Board meetings since the last RSC meeting, along with this report. LRCNA 37 was held on August 23, 24, and 25, at the Marriot Hotel in New Orleans and by almost any measure, was a great success. There were about 350 registered attendees, with 53 of those being newcomer packets. Registration appears to have brought in right around \$8,000.00. Merchandise also did well with an estimated income right around \$10,000.00. The auction and 50/50 raffle brought in right around \$2500.00 and fundraising over the time leading up to the convention brought in right around \$5,500.00. Overall, the convention appears to have brought in about 13,000.00 over what they spent and what they were given for seed money. The budget for LRCC for the coming year is about \$2600.00 which covers meeting space rental, legal filing fees, attorney fees, storage space, new card readers, and replacement of some materials used for the convention. This means the LRCC expects to make a donation to RSC of somewhere around \$12,000.00. It may be a little less or a little more than that depending on the final numbers which are still being worked out.

Given that 5 years ago, LRCNA's hotel in Alexandria was sold 6 months prior to the convention, leading to that committee having to scramble to find a new hotel, and this year LRCNA's hotel in Covington was sold and they reneged on our contract 30 days before the date for the convention, the board decided it should start checking on hotels with bids to make sure they are not up for sale. When we did that with the Best Western in Alexandria which we had signed a contract with for next year, we found that property is up for sale. The board discussed our options and asked the HCC if there were any other hotel's in Alexandria where the convention could be held. They reported the Holiday Inn would be an appropriate facility and agreed to go there and get a proposal. The board then voted to withdraw from our current agreement with the Best Western because the information that it was up for sale had not been disclosed during our negotiations. I notified the Hotel and told them we would be in touch for further negotiations, not knowing what we would find exploring a contract with the Holiday Inn. Those negotiations are occurring now. At our September LRCC meeting, Lori C., presented a bid for LRCNA 39 to be held in Lafayette. According to the bidding guidelines, bids are presented by persons interested in putting on the convention. This group of persons should be made up of people who are willing and able to serve on the HCC if they are granted the LRCNA by the RSC. A member ASC of the Region must endorse the bid and Lori reported that the Acadiana ASC has done this. Although it was not a unanimous vote, the board did vote to declare Lafayette's bid "valid," and to forward that to the RSC for voting. They are here today to present that bid. Also at our last LRCC meeting, as is our policy, we reviewed and updated the convention guidelines. Most of the changes were "housekeeping," in nature, but there is one change that we want to highlight. In general, there are two primary sources of income for a convention; Merchandise and Registration. Traditionally, HCCs offer an extremely low "preconvention" registration rate and then come up with the "full" registration fee to be charged at the door, and a timetable to decide when the "pre-convention" rate would be increased and by how much. We have had concerns about this in the past because it is simply getting more and more expensive to put on the convention and we cannot afford to "lose" money on "pre-convention" registrations. What I mean by that is, anytime someone purchases a registration at less than the full price, we are "losing" the difference. For example, there were about 100 people who paid a \$20 registration fee for LRCNA 37. On one hand, that represents about \$2000.00 income. On the other though, it represents \$1000.00 lost. The reason "pre-convention" registrations were offered in the past was to generate operating money for the committee. This is no longer needed though because LRCC gives the HCC \$5000 in operating funds right away. So, we have updated the convention guidelines to say that the minimum "preconvention" registration fee will be \$20.00, and it will ONLY be offered one day, the closing day of the previous year's convention. After that the registration fee will be no less than \$35.00. Finally, it has now been 4 years since the RSC voted to establish LRCC as a separate entity to oversee the LRCNA and terms for the board members serving since then are now up. Those members are myself, Virginia Williams, and Paul Payne. All of us have voiced a willingness to serve another term if you choose to elect us. Also, Rock Hudson from LRCNA 37 has voiced an interest in and a willingness to serve with LRCC. The next LRCC meeting will be held at 2:00 pm on November 10th at Grace Baptist Church on Richland Ave in Baton Rouge. That will be our "Annual" meeting where officers for the year are elected. If anyone is interested in attending, you are more than welcome to do so.

Meeting at Angola

Greetings all

The meeting at Angola is getting ready to celebrate its 5th year in November. The meeting has had its challenges. Mainly getting people approved to go in, but also dealing with the corrections officers that let us into the units and monitor the people from the inside attending the meetings. They have a job to do and so do we, gratitude is all that comes from these challenges. The rest and I of the volunteers that drive the hours to Angola, are grateful that we are allowed to have a meeting and be able to carry the NA message. We are also grateful, as are the members attending the meeting, for the financial support that the Region has given us, both financial as well as with volunteers.

We currently are only carrying a meeting into unit C, we are having problems to make a callout in unit D as well as getting those that are attending the meeting, that there is a callout at the meeting space. If this sounds complicated, it is. Angola is very large maximum-security prison, and they don't operate by our rules, and things don't always go smooth. We have been trying to start a meeting in the main prison for months. We have the people, the literature and the people in the prison wiling to host the meeting (its complicated). What we don't have is the space, we thought we did and were set to start in September, only to lose our space at the last minute. They hold over 900 events a month at Angola and were just going to try harder and wait until space opens.

Elmore is at the Regional meeting and should be able to answer any questions that you have. He is also one of the main people that go in, along with Roy and company and Ron D and friends. The group of people from New Orleans have been a very large part of this. Iron Bill has been leading a group of people out to Angola since the start. We are always looking for volunteers, orientation was today, the next one will be in January 2020. Hope to see you there. Bring a drivers license or an official state ID. We will not be going to Angola in October because of the Angola rodeo, which is yearly event and change how security is handled at the prison. We will return to our schedule of the second and forth week in November. I would like to request \$250.00 for literature for the prison meeting.

FIPT Operational Rules Workgroup Report to Conference Participants August 2019

The workgroup began its work focused on the inspection clause in Article V Section 3 of the FIPT Operational Rules. They had relatively long, involved, and very spirited conversations. Early discussions were framed around the change the board proposed at WSC 2018 and built on that. The workgroup tried to consider the audience and to provide enough information in this section that a member would understand how to work within the system. Much of the language in the first two paragraphs of the proposed revisions is taken directly from other sections of the trust and rules.

The easiest way to show the recommendations that we are making to you is in a revised track change version of the FIPT that accompanies this report. The title of this document is Proposed Changes to the FIPT Op Rules 0819. The changes for the inspection clause are shown on pages 16 and 17 of that document.

The new language that we are recommending to you for the inspection clause is:

SECTION 3: INSPECTION OF TRUSTEE ACTIVITIES

The Fellowship of Narcotics Anonymous, as given voice by its groups through their regional delegates at the World Service Conference, is the Settlor and the Trustor of the Trust. The Fellowship of Narcotics Anonymous as a whole is the Beneficiary of the Trust. Only the Trustor can request and conduct an inspection of Trustee activities on behalf of the Trust Beneficiary. With the exception of any items excluded by law, there are no limitations on what the Trustor can inspect.

Under Article IV, Section 12 of the Operational Rules, and in accordance with California law, Narcotics Anonymous World Services, as Trustee, is required to, among other things: (1) give a year-end financial report of the previous fiscal year; (2) cause an audit to be performed by an independent certified public accountant of the Trust for the previous fiscal year, and (3) deliver a copy of both the financial reports and independent audit to all participants of the World Service Conference.

If, after a review of the financial reports and independent audit, a member or service body has questions or concerns, they can contact the World Board. If questions or concerns still remain, after contacting the World Board, they would then be discussed through the established Narcotics Anonymous service structure. This discussion would be initiated by any region, through its regional delegate, submitting a request by motion to the Trustor, at the World Service Conference, through the Conference Agenda Report.

We have proposed other changes to the Operational Rules in the draft document provided to you.

The changes we are recommending now, in addition to the inspection clause, include:

 A change to the description of WSC Boards and Committees on page 11 of the Operational Rules

- Two edits to Section 12: Trustee Reporting Obligation on page 31 to change calendar year to fiscal year and to add independent to the description of the annual audit.
- Some "housekeeping" edits:
 - Changing representatives to delegates on page 24 of the readers notes
 - A straight copyedit by adding the world "the" on the same page and other edits on pages 15 and 31
 - A change to the way the inspection clause is described on page 37 of the readers' notes

We would have gone further in our recommendations, but we believe that it is important that the Rules and the FIPT be consistent, and any changes to the FIPT require a much different process. We cover proposed changes to the FIPT later in this report.

Use Policy - FIPT Bulletin #1

FIPT Bulletin #1, the Use Policy, explains "the NA Fellowship's policy on the reproduction and use of copyrighted NA fellowship-approved recovery literature and the use of registered NA trademarks and service marks by NA groups, service boards, and committees." The Use Policy is so drastically rewritten and shuffled that a track change version is very difficult to follow. We are providing a clean version and a track change version along with this report, and we will try to summarize the changes here.

The major proposed changes are:

- Changing the reproduction of recovery literature allowed by groups by adding current, removing book length pieces, and clarifying that this does not include any permission for electronic or on line formats.
- 2. Rewriting the introduction and moving the section on copyright ahead of trademarks.
- Using the term policy throughout the document, rather than a mix of policy and guidelines.

The World Board is only authorized to publish currently approved recovery literature. That would then mean that these are the only versions we can give someone else permission to reproduce. The Use Policy has never made that clear. Also, with discussions at previous WSC's, we have not given permission for anyone to post NA fellowship approved recovery literature online. We do post IPs and booklets, in a variety of languages, on www.na.org so that fellowship websites can directly link to this material. We do not post book length pieces of recovery literature online. Those clarifications, and removing the group's right to reproduce book length pieces are the largest proposed changes. Much of the explanatory text has been updated to reflect more current language, for example service bodies instead of committees.

FIPT Operational Rules Workgroup Report to Conference Participants August 2019

Information Given to Workgroup

The World Board provided the workgroup with the following information to begin their work:

The polling and decisions from WSC 2018 were:

Do you agree that a change is needed in the future to Article III of the Operational Rules? (this has no effect on the current inspection request)

Straw poll: 93-15-4-2 consensus support

Acting as the trustor, the delegates present at WSC 2018 are suspending Article 5, Section 3 of the FIPT Operational Rules, while we make a decision about the future. This suspension would expire at the close of WSC 2020.

Initial straw poli: 85-23-0-3 strong support

Final vote/decision: 89-22-0-2 consensus support

The W8 presented the following proposed change to the operational rules at WSC 2018, but no request was made to the WSC to make a decision on this.

SECTION 3: INSPECTION OF TRUSTEE ACTIVITIES

Conditions of inspection

Any regional service committee or equivalent service body The World Service Conference may inspect the records and operations of the Trust on behalf of the Beneficiary, providing the following conditions are met if it so chooses. The details of such an inspection would be decided by the WSC.

Explanation of the scope of the workgroup's role and task:

The Board explained to participants at WSC 2018 that a virtual workgroup would be created to review the FIPT Operational Rules and Bulletins, using the WSC 2018 actions and discussions as a guide. The workgroup will make recommendations to the World Board about potential changes to any of these documents. The WB will need to decide what to present in the 2020 CAR, based on the workgroup's recommendations but not bound by them. The Board has the responsibility to make their own recommendation and will need to keep ongoing communication with participants.

The workgroup will need to meet and draft recommendations early enough in the cycle to allow the WB to adequately discuss the workgroup recommendations and engage Conference participants in a discussion well ahead of the 2020 CAR deadline.

Operational Rules

As a reminder, the Operational Rules describe the way the FIPT is to be administered. Section 2 of the Operational Rules explains their purpose. This is a summary of the changes we are recommending that are all noted in the document that we are sending along with this report.




