Public Relations

I pray that everyone is well and staying home attending zoom meetings. I've been working on several projects, several of which will have to be put on hold until things get back to normal. Here is the status

of each one:

- 1. The Region phone line is set up and doing well but still is under utilized. Please help get the number out there. The helpline is set up to either forward to the appropriate area's helpline or directly to helpline volunteers in that area. Each area can log in to their own admin panel and schedule their own volunteers. It also has the capability to use an area's existing phone number if it is transferred to Twilio. North Louisiana Area is phasing out their helpline and using the Region number. It just made sense both economically and for effectiveness to do so. If anyone needs more information please contact me.
- 2. I have reached out to all the areas to get meeting information to keep the meeting database updated for meeting closures. Most of the meetings in the Region are closed. There are some meetings still showing as active. Please go to larna.org and look at the meetings in your area and double check if there are any errors and if so please contact me so it can be updated.
- 3. Zoom meetings are cropping up all over the Region. While it's not like physically being at a meeting, it is a godsend at this time. The meeting database is now set up to list online/phone meetings. Please send me your zoom meeting information if you wish it to be added.
- 4. Lamar Advertising had submitted a proposal for billboards for around the Region. The proposal is for fifty poster sized billboards distributed around the state. We would be paying their cost to make the vinyl and they would put them up wherever they have an unused billboard. The sign would stay up until the billboard is rented, which could be any where from a week to six months. This would cost us \$5000.00. For another \$5000.00 we can get an interstate sized billboard in each market. These can be reused and moved if the space is rented. We would also get free ads on the digital billboards in unused time slots (with either option). I have forwarded this information to Nikki and it should be attached to the minutes. At this time I don't think outdoor advertising would be effective, but look it over as it could be a good idea when things get back to normal.

There are other things in the works but are not applicable at this time. Hopefully in July things will start getting back to normal and we will address them at that time.

Information of Interest

To the Trusted Servants and Members of the Louisiana Region:

What follows is essentially a report from the LRCC for the upcoming RSC meeting, but the information is important, and we wanted to get it to you as quickly as possible.

Although I'm sure it will not come as a surprise, I am very sorry to have to inform you that due to the impact of Covid-19, the Louisiana Regional Convention of Narcotics Anonymous, scheduled for May 15-17, 2020 in Alexandria, is being cancelled.

This decision was not made without a great deal of thought and consideration of many factors. In the end though, it really came down to the safety of our members. For example, it seems likely that the Governor's order, making large gatherings unlawful, will be extended into May and that alone will make holding the convention impossible. Even if that order is not extended though, current predictions are that the infection rates in Louisiana will not level off for at least another 4-6 weeks at best. It will likely be at least another 3-6 weeks after that before people who have been seriously ill are back on their feet. Then there is the issue of folks being unemployed for a significant length of time due to the stay at home order, and simply not having the ability to attend a convention right now.

The Alexandria host committee had their own discussions on what would be the best thing to do for the fellowship and the chair, vice-chair, and treasurer were all involved in the process of LRCC making this difficult decision.

Now, we are preparing a statement for the website announcing the cancellation and hope to have that posted in a matter of days. The hotel will automatically cancel any reservations made for the convention with no penalties. The host committee will begin the process of contacting everyone who has registered and notifying them, as well as offering a refund. (Note: People who prefer, can have their registration "roll over" to LRCNA in Lafayette in 2021). LRCC will get in touch with vendors and notify them. Once we have detailed information regarding money that was lost in preparing for the convention, or made through fundraising and pre-convention merchandise, we will pass that on to you. Since this convention has been cancelled, LRCNA 2021 in Lafayette will be the 38th LRCNA and our attention will now turn to helping them get ready. All of the merchandise on hand for Alexandria will be turned over to Lafayette.

Again, all of us involved in putting together the LRCNA are very sorry that this decision had to be made, but keeping the safety of our members as our first priority, it seems to be the only responsible thing to do.
