January 2026 Chairpersons Regional Yearly Report

Good morning, everyone welcome and thanks for your service to your Area at LRSCNA. The main purpose of this January report is for me to give a brief review of how LRSCNA operates. One of the most important informational advice I could give y'all is to always refer to the newly printed LRSCNA Guidelines, that now has an easy-to-follow Table of Contents.

The primary function of the LRSCNA is to unify the Areas within the Region. The Secondary function of the RSC is to carry the message of recovery through the actions of the Fellowship Development Group and its defined workgroups. LRSCNA has ten areas that are acting participants. Each Area host a Quarterly Region Weekend Jan, April, July & October. The hosting area is on a predetermined rotation. Region is held on the 1st weekend of the month except for the month of January, it is the 2nd weekend of the month to avoid the holiday weekend. The Hosting Area is given 600.00 seed money to host region weekend. All money raised that exceeds seed money shall be split equally between the LRSCNA and the hosting area.

Regional weekend begins on Saturday, the schedule is made by the hosting area & the Vice Chair and is usually distributed two weeks prior. All members of NA are welcome to participate. All participants shall be subjected to the LRSCNA Guidelines. Saturday is also available on Zoom. All trusted servants must attend LRSCNA both Saturday & Sunday. Saturday consists of all Region Subcommittee Chairs & Reports & If there are new motions for Sundays Regional meeting, they are all discussed in full on Saturday.

Sunday is to conduct all Regional Business. LRSCNA shall conduct business only if a quorum is present by 10:30am. Only duly elected alternates are eligible for quorum in the representative's, no proxy representatives. Only If an Area has been absent for more than two inexcusable consecutive LRSCNA meetings that Area will not be calculated as part of Quorum. The agenda will follow the Regional Service Committee Meeting Format. All input and motions should be given to the Chairperson prior to old business at RSC meeting in writing. The Chairperson can add any new business to the agenda or revisit old business if deemed necessary. LRSCNA has two classes of Voting Participants which consist of ASR or ASR-Alt and the Administrative Committee as a whole, only in the case of a tie vote. Participants are only allowed to vote one time. In the case of an ASR or ASR-Alt serving as Administrative Officer they waiver their rights to vote at Administrative Committee in the case of a tie. Non-Voting Participants consist of Administrative Officers unless a tie, Standing Committee Chairpersons, Interested Parties, Volunteers & Observers.

On this initial spreadsheet, I've included budgets for this year's RSC. We currently have sufficient funds for all listed encumbered items, so any donations moving forward will simply add to our account. Most budget allocations are similar to last year, with subcommittee chairs, such as Fellowship Development, budgeting the necessary amounts to maintain operations like the phone line and website. There is currently no allocation for H&I, which we may need to consider if we fulfill our committee obligation to Angola Prison. I am also distributing a Statement of Assets (profit/loss statement) outlining all donations and expenses from last year. I hope we can discuss budgets and future donations during today's Subcommittee meeting.

Our liability insurance comes up for renewal in February. I will submit a motion today to purchase insurance for 2025, setting the spending ceiling with a 10% inflation allowance. I'll notify the ASR via Group Me of the new cost before renewing.

Before our next RSC meeting, I plan to file our annual paperwork with the Secretary of State's office (\$15 fee) and submit the 990N tax form to the IRS, ensuring we're fully up to date this year.

5. Regional Delegate Report – Bob St. – Report Submitted**Regional Delegates Report for January 2026 RSC meeting**

Hello all,

On October 18th we had a Zoom Conference Participants meeting in which Anthony, the outgoing Executive Director for NAWS reported that literature sales continue to be flat and 5% below what had been projected for their budget. He stated that costs across the board have increase and all of this has led to the decision to increase prices by 15%. The new literature prices are posted on the NAWS website by the way.

He also reported that, as you might have seen lately in some social media posts, the next WCNA is being planned for somewhere in Europe, although the final location had not yet been decided.

Irene, the WB chair reviewed what was then the upcoming CAR and the 5 motions that would be in it. I don't want to say a lot about these motions now as we will be spending a couple of hours next weekend going over all this. In addition to the 5 motions though, there will be discussion topics. MAT/DRT and Gender neutral language. The idea with these will be to get some sense of where the fellowship is on the issues around these topics.

The Conference Agenda Track (CAT) is due out next month and will address potential changes in processes as opposed to substance.

During the question and answer section of the CP meeting there was discussion about where and how the US Collaborations of Zones fits into the service structure. There also were comments and questions from Iran about allegations that the traditions and other literature are not legitimate as they were not truly "fellowship approved,"

On November 22nd there was a CAR workshop on zoom hosted by Southern Zonal Forum in which Irene and Veronica from the WB talked about the pending motions. Again, I hesitate to get into this too much as we will be going over all this next weekend in our own zoom CAR workshop. I do, however, want to emphasize that there is far too much content in the CAR to review all of it in a single workshop. This means that people need to read the content of the proposed IP, and the strategic plan for themselves. We will be able to tell you how it was

developed and what some of the concerns are, but you will have to be familiar enough with the content to say what you like and what you don't like, and in the end, yes or no to the motion overall. Similarly, with the discussion topics, y'all need to have some discussion at the group level about these issues and then tell us what your comments and concerns are so that we can voice these at the WSC.

There was another CP meeting on December 13th. We were reminded that there will be an initial straw poll on CAR items sometime after April 18th, so we have to have our regions votes no later than that.

There were concerns about other language translations of the CAR not yet being available. There was more discussion in this meeting about book length literature for incarcerated persons, and clarification of what the cost of such a thing might be.

Scotty and I both encourage you to advertise the Zoom CAR workshop we are doing next weekend and if people can't tune in live, there will be a recording of it on our RSC website they can access on demand.

We will take Area votes and discussion comments whenever you have them ready. We want all of this no later than the RSC meeting in April. We must have them by April 18th at the very latest.

Update on our submission of Bob Singer for a position on the World Board. Not only was he able to upload his information as required (finally), he also had a zoom interview with the Human Relations Panel. We will find out in the coming months whether he is being nominated or not and if he is nominated, the elections will occur at the WSC.

Finally, as in the Interim WSC conference, I ask for authority from the Region for Scotty and I to vote on issues we don't have a formal group conscience on, in the way we thing best represents our Region's conscience. If, however, we do not agree on what that is, we will abstain.

Policy, A&F, and H&I are vacant but our secretary is coordinating H&I and policy and A&F are handled on an ad-hoc basis.

The Black Sheep group in Springhill is hosting a pot luck and speaker meeting on Feb 7 and will also be hosting a birthday celebration for Daniel S (20 years) and Kenny R (21 years) on Feb 28. We will also be planning another major function for Monroe for early spring.
